Rationale

Center for Advanced Economic Studies (CEVES) announced a Call for Project Proposals "Towards Meeting the Sustainable Development Goals in Serbia: Job Quality and Economic Structure, How are They Linked?", on April 27th 2018, within the project "Using Sustainable Development Goals to Reposition Social Science Research: Pilot project". The project is supported by PERFORM (PERFORM is a project of the Swiss Agency for Development and Cooperation implemented by HELVETAS Swiss Intercooperation and the University of Freiburg).

Based on the Call for Project Proposal and Decision on the establishment and work of the Selection Committee for evaluation and selection of applications submitted under the Call, The Committee conducted the assessment and selection process of received applications, prepared and announced Report on the evaluation and selection process of applications with preliminary assessment and selection list. The preliminary assessment and selection list was published on CEVES website on July 13th, 2018. The applicants had the right to file a complaint within three days from the date of publication of the preliminary list of evaluation and ranking. Following the complaint deadline, the Committee determines the Final assessment and selection list. Since CEVES did not receive any
