

# Region Business Profile

## Kraljevo

### **Short Summary**

The Kraljevo area is located in the very heart of Serbia, in the Sumadija region. Within the project, partnerships have been established between Kraljevo, Cacak, Gornji Milanovac and Vrnjacka banja. Kraljevo is the second largest city in Central Serbia, behind Kragujevac. Thanks to its central geographic position, it connects North and South Serbia through roads M-22 and through railway. Being located 195 km from Belgrade, 130 km from the

border with Bosnia and Herzegovina and 175km from Montenegro, Kraljevo is a good connection route in the Balkans. Near the city there is a small airport "Ladjevci" which is used primarily for military purposes. Currently, it is being rebuilt to be the third largest commercial airport in Serbia, behind only that of Belgrade (distance 160km) and Nis (140km). With the Agro economical and Technical faculty in Cacak, the Kraljevo region offers a wealth of educated young people ready to contribute to the development of this area. This part of Serbia is enriched with woods and river systems enabling the irrigation of the fertile land, and is suitable for growing fruits such as apples, pears, raspberries and above all grapes. In addition to rich natural resources, there are many sources of natural and spring water in Vrnjacka Banja, the most well-known spa center in Serbia, which offers great possibilities to attract people not only from Serbia, but people from the entire Balkan region.

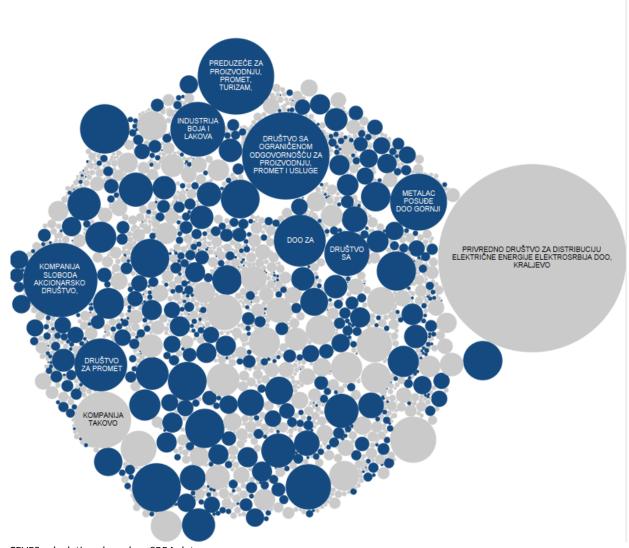

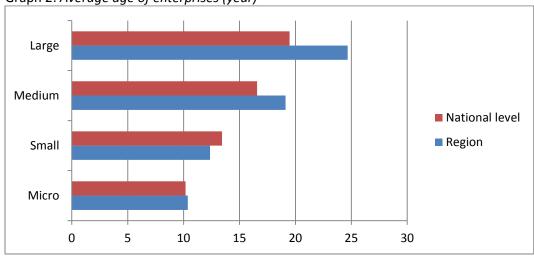

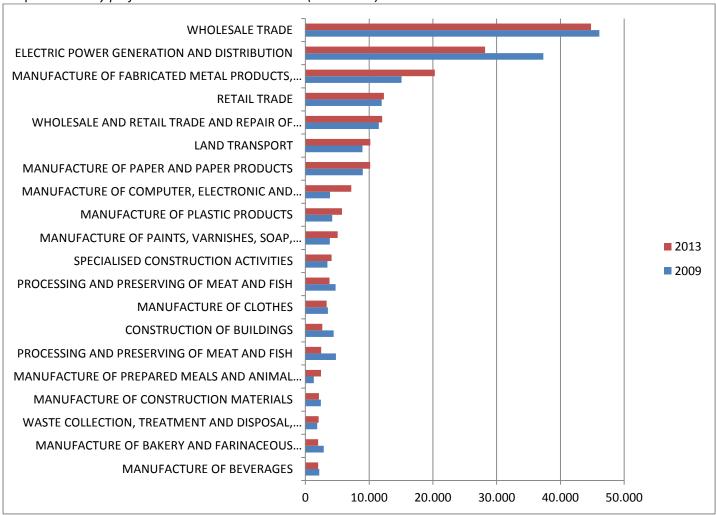
